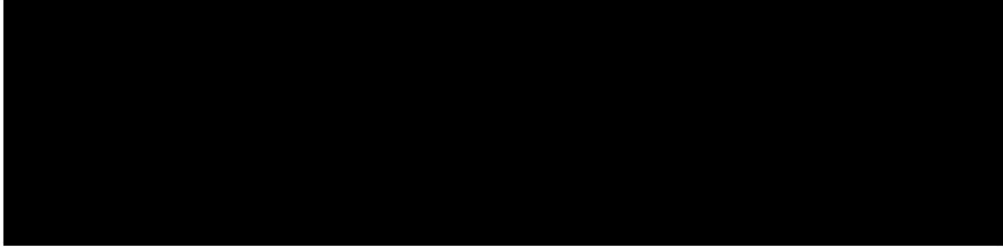

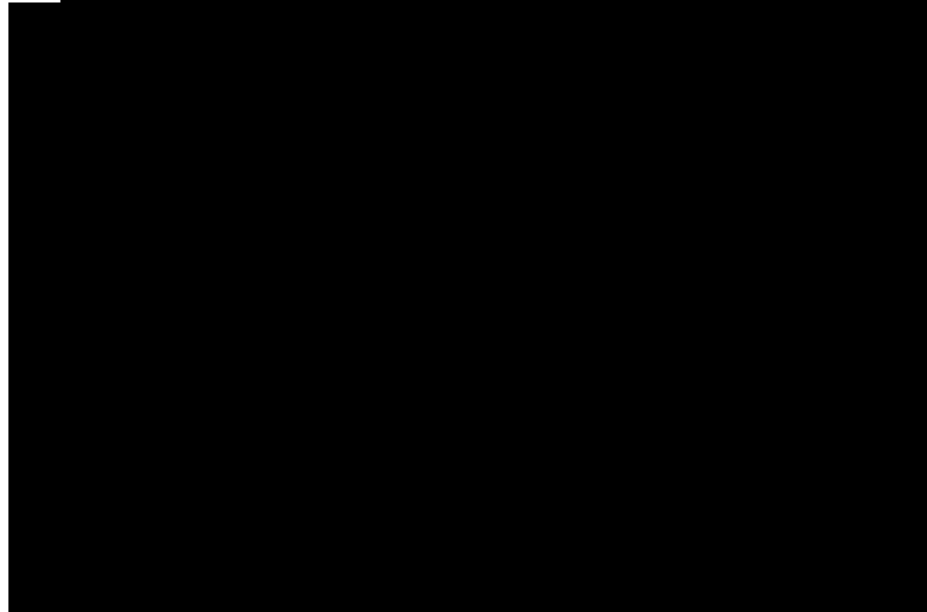

Dear Pam,

Removal of Notice from Parish Noticeboard

I write further to my email below of 11:59hrs on 24 October.

Details of this website were also provided via notices in the village yesterday, including on the parish noticeboard in a suitable location which was not compromising of the visibility of any other notices/information on the noticeboard - as per the attached photograph taken at 09:52am.

Unfortunately, upon checking the noticeboard, it has become apparent that in less than 24hrs our notice has since been removed.

Considering the various other information present on the

noticeboard and that Farnham has no formal Parish Council, I understand that the noticeboard is for the advertisement of all relevant Parish related information and unless you can provide me with formal Parish Minutes/Documentation to the contrary, that any persons in the village may use the noticeboard to display notifications of such information accordingly.

On this basis, the notice detailing our website - clearly disseminating factual, evidence based information in respect of the untruthful statements which have been made against ourselves and our planning application by six objectors in the village – including the Parish Meeting and several of its members in their personally capacity - is highly relevant to parishioners on whose behalf the Parish Meeting are meant to act justly and fairly on behalf of residents.

I am advised that both the Parish Meeting Chairman and yourself and your husband Mr Michael Taylor (who submitted the objection to our Planning Application on behalf of the Parish Meeting) were witnessed in the vicinity of the noticeboard yesterday and would hope that my notice was not removed by any of you. Indeed, were this to have been the case, I could only question why any members of the Parish Meeting would feel the need to remove my notice and could only assume that this would be because they do not wish for residents of our Parish to learn of the true facts and evidence in relation to our planning application, in the face of untruthful allegations by objectors – something which would again be entirely unjust and unfair, which is then all the more concerning when I am further advised that in his professional capacity, Mr Taylor was a Senior Judge in the British Judiciary system, entrusted with enacting justice.
